Information on processing:

Purpose of processing:

Categories of recipients:

Additional duties to inform:

Duration of storage of personal data:

Personal data is erased once its purpose no longer applies and there is no retention obligation in place. Emails are generally classified as tax-related documents and are stored pursuant to the legal requirements, in particular Section 147 of the German Tax Code (10 years) and Section 257 of the German Commercial Code (6 years).

Rights of data subjects:

As a natural person, you have the right to information (pursuant to Article 15 GDPR) from the data controller about your personal data as well as the right to rectification (Article 16 GDPR), erasure (Article 17 GDPR) and restriction of processing (Article 18 Paragraph 1 GDPR). You also have the right to object to processing (Article 21 GDPR) as well as the right to data portability (Article 20 GDPR).
